

Vaccinations - E-Passport App


INTRODUCTION

Weatherbys have developed a Vaccination App to benefit the industry in collaboration with BHA and the IHRB as the first part of a wider E-Passport project, the Vaccinations App enables digital capture of vaccination records of registered Thoroughbreds.

Ensuring that Thoroughbreds are not exposed to unvaccinated horses on the racecourse is a key part of protecting equine welfare. Maintaining accurate, up-to-date electronic records of vaccination dates of horses in training could allow entries to race being conditional on horses being correctly vaccinated. Less time spent by Veterinary Officers (VO's) manually checking vaccinations on raceday will allow time to carry out other veterinary duties related to equine welfare (eg. pre-race checks). The application will also be able to assist with identifying risk of spread in the event of another Equine Influenza outbreak, and aid informed communications with participants.

In light of the COVID-19 pandemic it is necessary to change operations on raceday to make things safer and as efficient as possible for all staff. Pre-clearing 'flu vaccinations in passports can help achieve this by reducing the need for staff to be near each other/handle a potentially contaminated object, plus it will prevent issues on raceday due to vaccination errors. Working with BHA we have updated the App and brought forward its release to assist with the pre-clearance programme.


Once you have summited the historical vaccination record for the horse and the vaccination history has been approved by the BHA all future and subsequent vaccinations between the pre-clearance and raceday should be uploaded directly into the Weatherbys App.



VACCINATION APP

The current practice for vaccination compliance involves veterinarians or regulatory officials checking all equine passports on arrival at racecourses on race day. On an average race day there will be 80+ runners to check. The Weatherbys Vaccination App will provide racing authorities with all vaccinations the minute they are recorded by the veterinarian or trainer with just a couple of clicks. Each vaccination uploaded will be digitally time stamped and saved. This will inform the racing authorities whether a horse is eligible to race or not and when it needs a booster vaccination reducing the risk of non-runners due to lapsed or incorrectly recorded vaccinations. The Vaccination App could develop to provide an automated vaccination tracking service for each horse to provide trainers, owners and veterinarians with updates and reminder notifications.

The Weatherbys Vaccination App interrogates data pre-raceday on one centralised digital platform, with direct data connectivity to the Passport Issuing Organisation (Weatherbys), the BHA, Irish Horse Racing Regulatory Board and Horse Racing Ireland.



QUICK START USER GUIDE

The objective of the Vaccinations App is to deliver digital vaccination records for all animals in training and racing, to allow for seamless collection of vaccinations data in real time. This data can then be used to link to the entry in the declarations system, to be used on the racecourse to reduce the need for passport checks and ensure vaccinations are up to date. This will support world class biosecurity of the British and Irish Thoroughbred herd.





DO

Ensure that the picture is in focus

Ensure the Passport Number for horses born from 2015, is visible

Assume that you will be able to bring a passport to the racecourse un-approved - we will not be able to handle passports on course

Ensure entries near the spine of the passport are visible



DO

Help us to let Trainers know that this is happening and to log in as soon as possible

Contact us if you are having difficulties


ADDITIONAL APPLICATION INFORMATION

- ✓ The App is a hybrid mobile App which will have both native and web view capability built upon a Microsoft Dynamics platform.
- ✓ The customer-facing or front-end App will be accessed via a mobile App and also via browser.
- ✓ The back-end administration of the Vaccination App will also be managed on a Microsoft Dynamics platform.
- ✓ The system is governed by a data share agreement between Weatherbys, BHA, HRI and IHRB.
- ✓ The App can be used by trainers and veterinarians to log vaccinations in real time via separate logins.
- ✓ Trainers and veterinarians can update vaccination records once logged into the App; they simply pick the horse from the list of horses logged as in training with them /under their veterinary supervision or they can find a horse by entering the microchip number or passport number.
- ✓ Once a horse is chosen the trainer or vet can upload historical vaccinations by taking a photo of the vaccinations in the passport and uploading them to the App.
- ✓ The Regulatory Authority is then able to approve the vaccination history clearing the way for future vaccinations to be lodged.
- ✓ Vaccinations uploaded by a trainer will need to be verified by the veterinarian that the trainer has assigned to them. This will be done from the veterinarian's version of the App. A trainer can assign a veterinarian to them from a list of veterinarians through the App and can remove a veterinarian from their assigned list if required.
- ✓ Once vaccinations have been verified by the veterinarian the vaccination status is marked as verified.



It is proposed that the E-Passport is the vehicle for a High Health digital passport which could fully integrate and deliver the documentation and authorisation required to identify, validate & record medications, move equines across borders and record ownership.
